- Bio-BOOST enrollments:32 ; **OHSU Network: 10.**

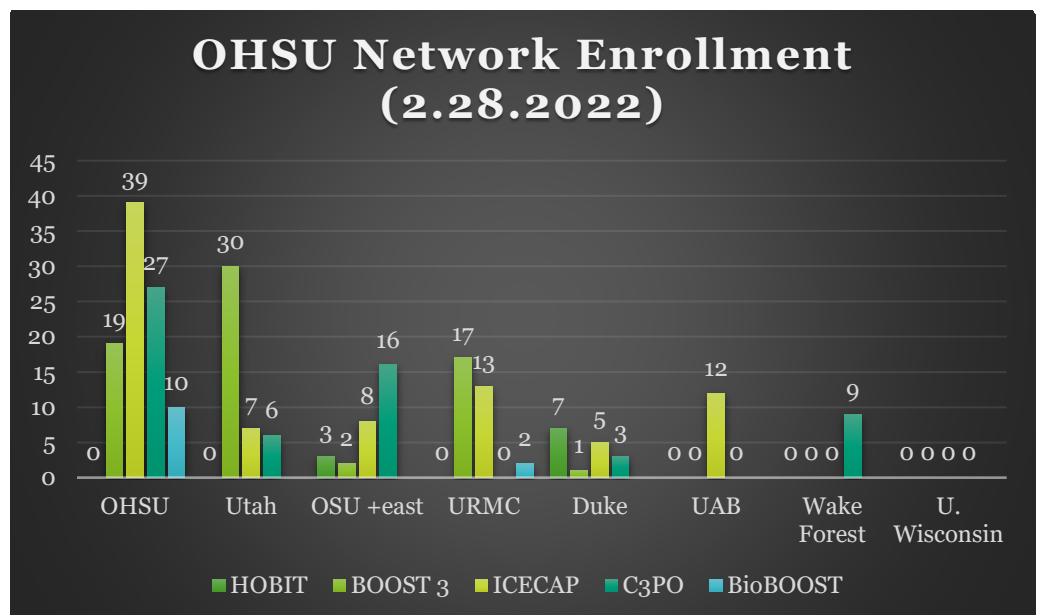

NETWORK NEWS & UPDATES



- ELECTROBOOST has started! There have been 5 subjects enrolled between the 3 sites currently open.

HOBIT NEWS & UPDATES

- Enrollment: 76 (Goal:200) 38% completed
- **OHSU Network enrollment: 10**
- Congrats to team Duke, who after having to pause enrollments for a number of months, was able to restart HOBIT and enroll a subject in February!

ICECAP NEWS & UPDATES

- Enrollment: 421 (Goal: 1800) 23% completed
- **OHSU Network Enrollment: 84**

C3PO NEWS & UPDATES

- ReConnects study – this is an NIH study that is reaching out to the subjects of all the NHLBI sponsored COVID trials for long-term follow-up. Subject contact is getting started. C3PO sites will not be involved in the contact of subjects – this is being done centrally by Stanford (and was covered in the C3PO Informed Consent form)

SPOTLIGHT ON SUBJECTS WHO WITHDRAW

When a subject or their LAR request to withdraw from a study, please be sure to clarify if:

- ✓ They want to withdraw from the treatment only
- ✓ They want to withdraw from the treatment and further data collection

There can be gradations of consent withdrawal and it is important to make sure you clearly communicate options and the risks and benefits of each option, and confirm with the subject or LAR which parts of the study should/should not continue.

GLOSSARY OF FREQUENTLY USED ABBREVIATIONS

CCC = Central Coordinating Center (i.e., University of Michigan)

DCC – Data Coordinating Center (i.e., Medical University of South Carolina)

EFIC= Exception from informed consent

CC = Community Consultation

PD = Public Disclosure

cIRB = Central IRB (in this case Advarra)
