

The OHSU SIREN Network Scholar Training Program in Emergency Care Research



Congratulations to Michelle Nassel MD, PhD, who was selected to be our first HONE-IT scholar! Dr. Nassel is an Assistant Professor in Emergency Medicine at The Ohio State University. Her research for her HONE-IT proposal focuses on defining real-time biomarkers of resuscitation, specifically Thoracic Impedance, in relation to resuscitation interventions and outcomes. - UPCOMING DSMB Meeting:
  - The Data and Safety Monitoring Board (DSMB) for the ICECAP study has scheduled a meeting to discuss the progress and data for the trial. In order to prepare for this meeting, we are asking that all subject data is up-to-date in WebDCU<sup>TM</sup> by September  $28^{th}$ , for the upcoming database freeze for the DSMB meeting. Please address any outstanding data, unresolved data clarification requests (DCRs), and open rule violations in WebDCU<sup>TM</sup> prior to the scheduled database freeze. Please note that you will still be able to access WebDCU<sup>TM</sup> during the database freeze, however, we need to ensure the data is as up-to-date as possible. DCC data checks will take place in the next 2-3 weeks for immediate issues that need resolved, and will result in additional DCRs written as well as email follow up. **Please remember to check your [Alerts] tab weekly.** If you have any questions or concerns please reach out to Peyton or Sara ( peyton@musc.edu, butlers@musc.edu) . Thank you for your continued hard work on the ICECAP study.
